Nominating Window: December 2, 2024 – February 28, 2025

- 2. Enter the name of the individual & organization you are nominating for the specific award category, with a brief description explaining your reasoning for the nomination (a maximum of 250 words). Additional information <u>is helpful to evaluate the nomination</u>, but not mandatory.
  - Company/Organization performance under her/his tenure as it relates to Latin America (with emphasis on the last 1-3 years). Please include board of Directors of company/organization.
  - Notable expansion/acquisitions over the last several years or successful initiatives/measurable impact in the region/industry.
  - Personal trajectory (impact on business or policy in the region over career), boards/organizations the person belongs to.
  - Exposure (any other awards received recently, etc.).
  - Additional Unique qualities/rationale to consider.
- 3. You may propose multiple nominations.
- 4. You may propose a new award category.
- 5. All nominations are strictly confidential.
- 6. Categories awarded vary from year to year, based on nominations received.



## **Description of Main Award Categories**

**BRAVO Legacy Award:** An individual who has transformed the region through a lifetime of dedication to the overall economic and social development of Latin America and the Caribbean.

**CEO of the Year:** The executive who has driven exceptional growth in profits and sales while successfully expanding into new international markets, leading a Latin American company with annual revenues exceeding US\$1 billion.

**Dynamic CEO of the Year:** The executive who has propelled a Latin American company's success through bold, progressive strategies, fostering expansion into new industries or markets.

**Innovative CEO of the Year:** The executive who has transformed their company by leading groundbreaking technology initiatives, driving growth and expansion into new sectors and geographies.

**Hemispheric Leader of the Year:** The government official whose far-reaching reforms have profoundly impacted a nation's economic development or public sector.

**Visionary Leader of the Year:** The executive who has impacted a Latin American company's trajectory, through a long term, strategic vision.

**Social Impact Leader of the Year:** The individual whose passion for improving lives has resulted in substantial social contributions to the region, through their leadership, philanthropy, and impactful initiatives.

**Entrepreneur of the Year:** A young leader who is inspiring Latin America's business landscape through innovation, entrepreneurial spirit and vision for shaping the region's future.

**Sustainability CEO of the Year:** The executive who has achieved outstanding sustainability milestones, setting new standards for environmental stewardship and corporate responsibility in the region.

**Investor of the Year:** The individual who has played a key role in driving investment opportunities and contributing to ventures that highlight the strength and dynamism of Latin America's business ecosystem.

**Digital Transformation of the Year:** The company whose innovative efforts have made the most significant impact on advancing technology and digital transformation for communities across the Americas.

**Company of the Decade:** The company that has achieved extraordinary success over the span of one decade, evolving from a local corporation in Latin America to a global leader with annual revenues exceeding US\$1 billion.
